**SCHEDULE****Definitions**

1. In these regulations "the Regulations" means the Regulations on the Fees for Consideration and Processing of Applications for Environmental Authorisations and Amendments thereto, 2014 published under Government Notice No. 141 of 28 February 2014.

**Amendment of Regulation 4 of the Regulations**

2. Regulation 4 of the Regulations is amended as follows:
  - (a) by the substitution, in subregulation (1), for the word "applicant" of the word "proponent";
  - (b) by the insertion, in subregulation (4)(a), of the words "in terms of the ECA Regulations or the previous NEMA Regulations" after the word "rejected"; and
  - (c) by the substitution, in subregulation (6), for the words "Where an application for which a basic assessment is required, is lodged," of the words "Where an application for basic assessment is lodged,".

**AMENDMENTS TO THE REGULATIONS ON THE FEES FOR CONSIDERATION AND

**Definitions**
