## **ENVIRONMENT CONSERVATION ACT 73 OF 1989**

### **REGULATIONS: RESERVATION OF LAND AS A NATURE AREA – RIETVLEI AREA**

#### **DEPARTMENT OF CONSTITUTIONAL DEVELOPMENT AND PLANNING**

Under and by virtue of the powers vested in me by section 4 (1) of the Physical Planning Act, 1967 (Act 88 of 1967), I, Jan Christiaan Heunis, Minister of Constitutional Development and Planning, after consultation with the Minister of Agriculture, the Minister of Mineral and Energy Affairs, the Minister of Environment Affairs and Fisheries and the Administrator of the Cape Province, hereby declare that the land defined in Schedule A, shall, as from the date of publication of this notice, be reserved as a nature area as defined in section 1 of the above-mentioned Act.

#### **SCHEDULE A**

##### **BOUNDARY DESCRIPTION: RIETVLEI NATURE AREA**

Beginning at Beacon P on the diagram of Erf 17, Milnerton; thence north-eastwards in a straight line to Beacon O on the said diagram of Erf 17; thence south-eastwards in a straight line to the southernmost beacon of Lot 1 (as shown on the General Plan M.53a of Milnerton Estate) of Erf 3; thence north-eastwards in a straight line to the southernmost Beacon (a) of Erf 5; thence north-eastwards along the south-eastern boundary of the said Erf 5, so as to exclude it from this area, to Beacon m on the diagram of the said Erf 5; thence generally northwards in a series of straight lines through points 1, 2, 3, 4, 5, 6, 7, 8, 9 and 10(1) thence north-eastwards in a series of straight lines through Beacons T and Q on the diagram of Erf 1952 to point 11; thence north-westwards in a series of straight lines through points 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26 and 27; thence north-westwards in a straight line to Beacon N' on the diagram of Erf 10787; thence generally north-eastwards along the eastern boundary of the said Erf 10787, so as to exclude it from this area, to Beacon E' thereof; thence north-eastwards in a series of straight lines through points 28 and 29 to the westernmost beacon of Erf 4786 (Table View Township TP 392); thence south-eastwards along the boundary of Erf 9368 to Beacon M on the diagram thereof; thence south-eastwards in a straight line to Beacon D<sup>2</sup> on the said diagram of Erf 9368; thence south-eastwards along the south-western

and south-eastern boundary of Table View Extension 13 (TP 10541), so as to exclude it from this area, to the southernmost beacon thereof; thence eastwards in a straight line to the southernmost beacon of Erf 5477; thence south-westwards and generally eastwards along the boundary of Table View Extension 7 (TP 8414), so as to exclude it from this area, to the easternmost beacon thereof; thence north-eastwards along the north-western boundary of Erf 9367 to Beacon A on Servitude Diagram 1592/1966 (D/S 183/1967); thence north-eastwards in a series of straight lines through points 30, 31, 32, 33, 34 and 35 to the northernmost Beacon (A) on the diagram of Erf 10781; thence south-westwards along the north-western boundary of the said Erf 10781, so as to exclude it from this area, to the westernmost beacon thereof; thence south-westwards in a straight line to point 36; thence south-westwards along the north-western boundary of Erf 1945, so as to exclude it from this area, to the westernmost beacon thereof; thence south-westwards in a series of straight lines through point 37 to Beacon F on Pipeline Servitude Diagram 5074/1957 (D/S 227/1961); thence generally south-westwards along the western boundary of the said pipeline servitude to point 38; thence south-westwards in a straight line to Beacon C on the diagram of Erf 10983; thence southwards along the eastern boundary of the said Erf 10983 to the southernmost beacon thereof; thence south-westwards in a series of straight lines through points 39, 40, 41, 42, 43, 44, 45, 46, 47, 48 and 49 to the northernmost beacon of Erf 1935; thence south-westwards along the boundary of the said Erf 1935, so as to exclude it from this area, to point 50; thence generally southwards in a series of straight lines through points 51, 52 and 53 to Beacon A on the diagram of Erf 10620; thence generally southwards along the western boundaries of the said Erf 10620, Erven 10622 and 10621 to the westernmost beacon of the last-mentioned erf; thence south-westwards in a straight line to the northernmost beacon of Erf 6156; thence south-westwards along the western boundary of the said Erf 6156, so as to exclude it from this area, to Beacon K on the diagram thereof; thence south-westwards in a straight line to point 54; thence westwards in a straight line to the said Beacon P on the diagram of Erf 17, the point of beginning.
