**4.2 SUSTAINABILITY: Environmental Management – Air Quality Improvement Plan**

**IT WAS RESOLVED THAT:**

The Social, Ethics and Sustainability Committee **approved:**

- 4.2.1 the Air Quality Improvement Plan, as recommended by EXCO on 28 July 2016, including:
- execution of the emission reduction programme, as committed to the authorities and public in Eskom's postponement application to achieve partial compliance with the Minimum Emission Standards and subsequently revised based on Eskom's CAPEX allocation, as detailed in the submission;
  - large-scale roll-out of air quality offsets as per Eskom's Air Quality Offset Implementation Plans, as detailed in the submission;
  - emission reduction and air quality offset costs to be demarcated in the MYPD4 and MYPD5 tariff applications with investment approvals to be obtained for individual projects; and
  - appropriate legal channels to be followed to seek additional postponement of compliance to 2020 emission standards and longer timeframes for execution of the flue gas desulphurisation retrofits.
