DESIGNATION OF THE MUSINA-MAKHADO SPECIAL ECONOMIC ZONE

Your application for the designation of the Musina-Makhado Special Economic Zone refers.

It gives me great pleasure to inform you that, after considering the recommendations of the SEZ Advisory Committee and in consultation with Cabinet; I have approved the designation of the Musina-Makhado Special Economic Zone. This special economic zone is designated for the following economic activities and their related industrial value chains:

6. Energy,
7. Mineral beneficiation,
8. Petro-chemicals,
9. Agro-processing, and
10. Other support industries.


Please note that currently support industries such as logistics cannot benefit from the applicable SEZ tax incentives. As per the designation application, the license for the Musina-Makhado Special Economic Zone is awarded to the Limpopo Economic Development Agency (LEDA). Arrangements for the official award ceremony for the license shall be finalised by the dti in consultation with your office and the LEDA.

The Musina-Makhado SEZ will comprise various and distinct industrial parks. One of the industrial parks within the SEZ is the South African Energy and Metallurgical Industrial Park initiated by the Hong Kong Hoi Mor Industrial Group. Given the kind of expertise and competence required to successfully develop and expand the metallurgical complex, I have decided that the Hong Kong Hoi Mor Industrial Group shall be responsible for the planning, development, management and marketing of the SA Energy and Metallurgical Industrial Park.

In this regard, Hong Kong Hoi Mor Industrial Group and the LEDA must complete the necessary contractual arrangements. The SA Energy and Metallurgical Industrial Park can also be branded and marketed separately but within the broad framework of the Musina-Makhado SEZ.

I congratulate you on this milestone and look forward to cooperating with the Limpopo Province and your office to promote industrial development through the Musina-Makhado SEZ and other platforms.
