**AFFIRMATION THAT RECORD REQUESTED DOES NOT EXIST (PROMOTION OF ACCESS TO INFORMATION ACT NO 2 OF 2000, SECTION 23) – KENDAL COMPLIANCE QUERY**

In respect of the above PAIA request I confirm the following:

1. Your query point II – maintenance plan for Kendal - I confirm that Eskom has to date not submitted a maintenance plan to the Department of Environment, Forestry and Fisheries in respect of this matter. Eskom is however continuing with maintenance at the station and has prepared the required maintenance plan which is being reviewed by independent specialists.
2. Your query IV - decommissioning information – I confirm that in Asset Management it is an accepted principle that the life of an asset is not a function of age, but that of the economics of continued operation. However, to produce long-term asset management plans, Eskom uses an age-based life expectancy, which is then adjusted by the economics in the short-term.

For long-term planning purposes, Eskom uses an age-based life expectancy of 50 years for a coal unit. However, at the appropriate time, Eskom undertakes a study to determine whether it is technically, environmentally and economically viable to extend the life beyond 50 years. Due to present capacity constraints and in order to allow opportunity for other stations to undertake maintenance it has been decided to continue with the operations of Grootvlei, Camden, Hendrina with station shut down occurring by 2030, investigations in respect of this are underway.

The present decommissioning schedule based on the above and shared is provided in Table 1 below.

In light of the above there are no decommissioning assessments or plans available to be provided in terms of this PAIA request.
