You are hereby given notice that your request for access to records has been **partially granted** in terms of the Promotion of Access to Information Act, 2000 (Act No. 02 of 2000).

The requested records have been granted with the exclusion of copies off correspondence between the DMR and Mineral Sand Resources / Mineral Commodities Limited regarding section 102 amendment application as well as supporting documents.

Subject to subsection (3) and (4), the Information Office of a public body may, in terms of section 44 (1) (a) of the Act, refuse a request for access to a record of a public body if the record contains an opinion, advice, report or recommendation obtained or prepared or an account of a consultation, discussion or deliberation that has occurred, including but not limited to minutes of a meeting for the purpose of assisting to formulate a policy or take a decision in the exercise of a power or performance of a duty conferred or imposed by law.

Please note that access to the granted documents will be given upon payment of the said fees.

Take note that a requester may lodge an internal appeal against a decision of the Information Officer/Deputy Information Officer of the Department to refuse a request for access to records. Such internal appeal must be lodged in terms of Section 75 of the Act.
